ESTABLISHMENT OF THE ENTRY FEE

ORIGIN:

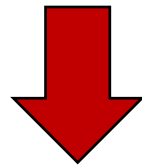
Art. 1 par. 1129 of the **law of 30 December 2018, no. 145** (Budget Law 2019) provided that: “The Municipality of Venice is authorized to apply to any carrier entering the Old City and the other smaller lagoon islands the fee referred to in article 4, paragraph 3-bis, of Legislative Decree of 14 March 2011, as an alternative to the tourist tax referred to in paragraph 1 of the same article, up to the maximum amount referred to in article 14, paragraph 16, letter e) of Decree-Law no. 78 of 31 May 2010, converted, with amendments, by Law no. 122 of 30 July 2010.

Textual amendment introduced by art. 12, paragraph 2-ter of Decree Law of 30 December 2021, no. 228, converted by the **Parliament** with amendments by the **Law dated 15 February 2022, no. 15** which provided for the establishment and governing of the entry fee **also "carrierless"**.



REGULATION FOR THE ESTABLISHMENT AND GOVERNING OF THE ENTRY FEE

First Regulation approved by the City Council in 2019.



New Regulation approved by resolution no. 51 of September 12nd 2023 of the Venice City Council



REGULATION FOR THE ESTABLISHMENT AND GOVERNING OF THE ENTRY FEE

The Entry Fee is intended to curb "**hit and run**" day tripping, through an innovative measure provided for in a National Law: inviting day-trippers to choose alternative dates.

The aim is to identify a **new balance between residents, city-users and visitors** of the Old City, who wish to experience positive emotions in the UNESCO World Heritage Site since 1987. It is not a tool for "making cash," far from it.



THE "HEART" OF THE SYSTEM

A **multichannel** and **multilingual** platform, created by **Venis SpA**, at the following address: **<http://cda.ve.it>** from which you can obtain the title (**QR Code**) to be shown in case of checks. This title certifies the payment of the Fee or the exclusion/exemption condition.

The platform will be active from January 16th, 2024.



TRIAL FOR THE YEAR 2024

City Council resolution of November 23rd, 2023:

Determination of the entry fee amount and identification of enforcement days in the first trial implementation in the year 2024.



TRIAL FOR THE YEAR 2024

The entry fee is applied as an **alternative to the tourist tax** and must be paid by **every person accessing the Old City**, subject to the following exclusions or exemptions.



NOTES:

For the year 2024, the entry fee **will NOT be applied to the smaller islands**, including Venice Lido (including Alberoni and Malamocco), Pellestrina, Murano, Burano, Torcello, Sant'Erasmus, Mazzorbo, Mazzorbetto, Vignole, S. Andrea, La Certosa, S. Servolo, S. Clemente, Poveglia...

It is NOT due by those transiting Piazzale Roma, Tronchetto or the Maritime Station, without accessing the Old City.



TRIAL FOR THE YEAR 2024

The amount: **5.00 €** a day



NOTE: The amount is **UNIFIED** and will not be subject to reductions. For the year 2024 an attendance threshold above which to apply a surcharge on the entry fee has **NOT** been identified.

EXCLUSIONS: RESIDENTS AND PROPERTY OWNERS

TRIAL FOR THE YEAR 2024

RESIDENTS OF THE MUNICIPALITY OF VENICE will be able to prove their condition in an **easy way**. Those born in Venice can also show their ID.

PROPERTY OWNERS NOT RESIDING IN THE CITY and their family will have to register on the platform to obtain a **long QR Code** (if in good standing with IMU property tax payment).



EXCLUSIONS: WORKERS AND STUDENTS

TRIAL FOR THE YEAR 2024

The following will **NOT** have to pay the fee, **BUT will have to book** through the web-app, outlining the dates when they intend to visit the city (if they are alert days): **WORKERS** who need to reach the Old City **occasionally** for their business, **STUDENTS** on an study trip or visit.

The following will **NOT** have to pay the fee and will have to register on the platform to get a **long QR Code**:

- **STUDENTS**, including commuters, attending all schools with a **stable executive office** in the Old City
- **WORKERS**, employees and self-employed, including commuters, with a **stable executive office (also temporary)** in the Old City.



EXEMPTIONS AT A GLANCE

TRIAL FOR THE YEAR 2024

For the day visit to Venice on the days when the trial is active **the following will have to BOOK (but are exempt from the Entry Fee):**

- Tourists who are host in the Municipality of Venice, temporary residents, **Veneto residents**, children under 14, people with certified disabilities and accompanying people, those in need of medical examinations or therapies, accompanying people or visitors of hospitalized patients, athletes of CONI sporting events in the Old City, tenants, spouses, from first- to third-removed relatives and people visiting residents of the Old City (*non-exhaustive list, complete list under art. 5 of the Regulation*).

WHO HAS TO PAY THE ENTRY FEE?

TRIAL FOR THE YEAR 2024

In summary, all the visitors who **do NOT stay overnight** in the Venice municipal area, intend to visit Venice on the **dates when the trial is active** and **do NOT reside in Veneto**.

For these visitors, in 2024 the **reservation will be mandatory** and the amount to be paid is 5.00 euros a day.



HOW DOES THE COLLECTION TAKE PLACE?

TRIAL FOR THE YEAR 2024

Directly from the **Municipality of Venice**, either through a **dedicated web-app** at <http://cda.ve.it>, and at **desks or electronic kiosks**.

WARNING: Evidence of payment of the entry fee or of the exclusion or exemption status should be retained and shown upon request to inspection personnel



CONTROL AND ASSESSMENT PROVISION

TRIAL FOR THE YEAR 2024

The Municipal Administration may use the tools provided for by the regulations for the **recovery of evasion** and **avoidance** and in particular **carry out checks, inspections** and **site visits** through authorized **personnel**, in the principal points of access to the City.

Fine from **50 euros** to **300 euros** (+10 euros of the entry fee), with the possibility of reporting under the **Italian Criminal Code** and special laws on the subject to anyone who makes **false declarations**, and **falsification of documents** in the cases provided for by the **Regulation**.

If they are not **paid** within the **term** outlined in the notice served, the recovery of the **amounts** is **enforced** in accordance with the provisions of current tax regulations.

Applied **ONLY** to the old city of Venice, **NOT** to the smaller islands

GOAL: managing daily visitors, diverting them to other dates

CHECKS by dedicated staff

RESERVATION REQUIREMENT also for workers, students and exempted people

FINES from €50.00 to €300.00
